



3. About privacy with Windplanner business and website

3.1 How does Windplanner use your personal data?

Underneath you will find an overview of the purposes for the processing of your personal data. You will also find a specification of which data Windplanner uses for that specific purpose and the legal justification. For clarity's sake, we have categorized the purposes. Windplanner keeps the data only as long as strictly required for its purpose.

3.2 How did we obtain your personal data?

Windplanner has obtained your data because you have provided this data to us.

3.3 What are your rights?

Under the European General Data Protection Regulation you have a number of rights with regard to your data and the processing thereof:

Access

you may access your personal information and make any necessary changes. If you would like to see which personal data Windplanner has obtained about you, you may exercise your right of access by submitting a request to Windplanner.

Making changes

If you wish to make changes to the personal information that you have seen as a result of a request for access and you are unable to make the changes yourself in your account, you may request that Windplanner makes these changes for you. You may request that Windplanner modifies, corrects, supplements, erases or shields your information.



Restriction of processing of personal data

You also have the right, under certain conditions, to ask Windplanner to restrict the processing of your personal data.

Right to object

If processing of your data takes place on the grounds of 'legitimate interest' by Windplanner or a third party, you have the right to object to that processing.

3.4 Portability of data

You have the right to obtain your personal data from Windplanner. Windplanner will provide this in a structured and commonly used format, which can easily be opened using commonly used digital systems.

3.5 Withdrawing consent

When the legal basis for a particular processing is your explicit consent, you have the right to withdraw that consent. This does not affect past processing, but does mean that we will no longer be allowed to process this data in the future. It may also result in Windplanner no longer being able to provide you with certain services.

3.6 Response from Windplanner

A request can be sent to administratie@theimageers.com. Windplanner will comply with your request as soon as possible and in any case no later than one (1) month after Windplanner has received such a request. If Windplanner rejects your request, we will indicate in our reply why the request was rejected.

3.7 Recipients of your personal data

It is possible that Windplanner is required to submit your data to a third party, for example to fulfil a legal obligation.

3.8 Can changes be made to this Privacy Statement?

This Privacy Statement is subject to changes. We therefore advise you to regularly read the Privacy Statement for any such changes.
